



Human Resources New Technology Quarterly Summary: Q2 2021



Introduction

The rate of new technologies being developed and companies providing them is exponentially increasing each year. To track the players and the innovation they bring, *HRO Today* Magazine produces quarterly reports that summarize activity in technology advancements and funding initiatives that support product innovation in the HR world.

This data reveals critical information about new technologies, their applications, and the companies offering them in the human capital management (HCM) technology sector. HCM systems covered in this summary are those that include recruitment, employee records, performance, learning and compensation management, and compliance.

The report is organized by months in the quarter, and then further divided within those months by the type of activity reported. There are announcements focused mostly on products, funding announcements for companies providing HR technology solutions, and merger and acquisition activity that had direct technology implications for HR.





Second Quarter 2021 Overview

The frequencies and funding of announcements for advancing technologies to support human resources in the second quarter of 2021 remained high. In total, there were 150 major announcements (those with at least \$1 million in funding), up slightly from 145 announced in the first quarter of 2021.

Private equity and venture capital firms continued to invest heavily in HR technology, totaling \$4.37 billion in the quarter, up a substantial 41% from Q1 2021's \$3.10 billion. The average investment increased to \$49.1 from \$32.0 million in 1Q 2021. The number of announcements and associated funding for HR technology were the highest reported in any quarter for more than four years and continue the upward trend from 1Q 2021.

One hundred one of the announcements were from companies located in the United States, five from Canada, 21 from EMEA, 12 from APAC and one from Latin America. Additionally, there were ten joint announcements by geography: seven US/EMEA, and three US/Canada. In the United States, 30 of the announcements were from companies in or near Silicon Valley, while in the EMEA region,

Most announcements were around funding for small or start-up organizations, though there were fifteen announcements of at least \$100 million.

5 were from London-based companies. The most common type of announcement was funding-related, with 93 citations. There were 29 product and 29 merger and acquisition announcements. While funding-related activity always accounts for the bulk of announcements, product-related announcements rose by 70.6% from Q1 2021.

Most announcements were around funding for small or start-up organizations, though there were fifteen announcements of at least \$100 million. The largest investment announcement came in the amount of

\$500 million from DailyPay. The New York, NY-based company plans to use the investment to expand into new markets and extend its market leadership position in employee on-demand pay.

The next largest announcement for \$300 million was for Workrise. Workrise, located in Austin, TX, offers a platform that connects skilled laborers with companies in the energy sector.

Another particularly significant investment of \$280 million was for Collective Health. Collective Health provides an integrated solution that allows self-funded employers to administer plans and control costs. The company will use the funding to enhance its platform so companies and individuals can more easily understand, navigate, and pay for healthcare.





Artificial Intelligence (AI) and machine learning technologies continued to be a major part of new technology in the second quarter, with 17 announcements totaling \$622.7 million in funding. Companies continue to adopt the technology for HR purposes, and emphasize its inclusion.

Human Capital Management (HCM)/Core HR includes a broad array for HR department areas of responsibility and accounts for the single largest area of investment at nearly \$1 billion dollars. There were more announcements for Marketplace Job Boards (14) than any other area, other than HCM. The largest areas of funding are show below, with remote working included due to its significance as the world economy recovers from the impact of COVID-19. Note that while employee Mental Wellness had five announcements totaling \$256 million, \$200 million of that was for Lyra Health.

Given the high level of investment being made in talent acquisition technology as part of HCM and marketplace job boards during the second quarter, talent leaders will need some guidance in sorting out what it all means. 5 Key Technology Improvements for TA Success

With the growing investments and developments in recruitment technology, today's talent acquisition leaders have endless options to make the hiring process more efficient for hiring managers and candidates. The industry has certainly come a long way since the first applicant tracking system (ATS) I used in 1993—the now antiquated Resumix 2.1. While the core capabilities of applicant tracking remain, advancements in technology mean TA teams can handle larger volume, receive more valuable insights, and deliver results faster.

To help talent leaders understand how tech-enabled talent acquisition can improve TA functions and outcomes, here are five key tech advancements I believe you should incorporate into your TA strategy:



Al Matching

Systems today offer artificial intelligence (AI) tools for matching candidates to job requisitions, helping identify quality talent quickly. Using AI and algorithms, this technology can search a company's talent database and external job boards to provide hiring managers a ranking of candidates based on who best fits the qualifications. While the AI matching tool varies depending on the provider—some run automatic searches and present results, others deliver results based on provided criteria—it is made to efficiently deliver ideal candidates for the job.



Intelligent Automation

The ability to perform bulk actions on a set of candidates is now a reality with intelligent automation, allowing recruiters to focus on business-critical tasks. This feature means recruiters can swiftly move candidates through the interview process, from resume review to scheduling to interviews. It removes the potential human error by prompting recruiters and others involved in the hiring process on pending activities, delays, interview confirmations. Intelligent automation not only saves time, it helps improve the hiring experience for both hiring managers and candidates, whether they get the job or not.







Predictive Analytics

Instead of manually tracking the performance of talent acquisition strategies, predictive analytics delivers talent acquisition teams with real-time insights and process recommendations. When creating a new requisition, predictive analytics allow hiring managers to quickly see the results of similar requisitions, including best sources for hire, time-to-fill, and candidate flow. These useful insights ensure you are not starting from scratch each time you open a new requisition. This both saves time and delivers more valuable observations to drive better outcomes.



Conversational Al

Just a few years ago, the talent acquisition community was excited about the ability to text candidates using a chatbot. Nowadays, chatbots can take candidates through the entire recruiting process. Conversational Al works across devices and creates a personal yet consistent experience for candidates. Though chatbots are incredibly beneficial, they are not the end all be all. There are times when candidates will need to connect with a member of the talent acquisition team to answer more in-depth questions or if they just want to talk to a person.



Platform Model

With the number of disparate systems used in recruiting today, technology integrations are increasingly necessary to support talent acquisition outcomes. A cloud- or platform model is a fully integrated approach that manages the candidate relationship management system, ATS, and onboarding, allowing data to seamlessly flow between the systems. It provides a framework that can be executed at scale based on stakeholder and business needs, now and in the future. The future of TA technology is increasingly platform-based, with an ecosystem of apps or point solutions catering to different use cases or shifts in the market while maintaining a centralized place from which to work, drive experience, and manage data.
