

Q4 2011: Certification program creation is slated for 2012

Initially discussed in Spring 2012 by HROA, tabled July 2012.

- Individual vs Organization
- Committee Team subset of Research and Publications Committee

Q4 2018: Certification Program concept is presented to Summit and HRO Today Forum EMEA attendees

- Positive feedback from attendees
- Interest from majority to assist
- HRO Today resources and membership increased
- Bakers Dozen focus is on customer experience, certification focus is on provider expertise (qty vs quality)

Q1 2019: Certification program creation is slated for 2019

Program concept revealed at Summit and HRO Today Forum EMEA
Certification Committee is formed first meeting is February 13, 2019 to assist in discovery, development and process review


