

Human Resources New Technology Quarterly Summary: Q3 2022



Introduction

Each quarter, new technologies in the HR space are developed at record rates. To track the key players in the human capital management (HCM) technology sector and the innovation they bring, HRO Today produces quarterly reports summarizing the top advancements in the industry and the funding initiatives that support product innovation. This data reveals critical information about today's industry leaders, new technologies, and their applications.

The HCM systems covered in this summary are those that include: recruitment, employee records, performance, learning and development, compensation management, and compliance tools. The quarterly report features new products hitting the market, funding announcements for companies providing HR technology solutions, and merger and acquisition (M&A) activity with direct implications for HR technology.



Third Quarter 2022 Overview

2022 has proven to be an overall nightmare for venture capital funding. According to Crunchbase, a leading provider of investment and funding information, North American startup investment for the third quarter of 2022 totaled less than half of its year-ago levels, driven by an even steeper drop in late-stage financing. Investment pullback that commenced earlier this year has intensified in recent months, as tech valuations in public and private markets contract and the IPO window remains largely shuttered.¹ European venture funding for third-quarter 2022 was no better, sliding to its lowest point in nearly two years as early-stage investment shows clear signs of weakness.²

Investment in HR technology has not been immune to the overall malaise in capital funding. While the funding and development of HR technologies in the third quarter of 2022 remained substantial, it was far less than

what has occurred in recent quarters. In total, there were 107 major announcements (those with at least \$1 million in funding) in the quarter, down substantially from the 174 in the second quarter of 2022 and about one-half as many as the third quarter of 2021, which had 207 announcements.

Private equity and venture capital firms' investment in HR technology totaled \$1.16 billion in the third quarter, with about one-quarter the \$4.70 billion invested in

the second quarter of 2022. The amount of investment was also down a remarkable 82.1% from Q3 2021's \$6.48 billion. The average investment in the second quarter was \$27.1 million, about one-half the \$54.1 million in the second quarter and 39% of the \$69.7 million average investment year-over-year.

Of the 107 technology announcements: 82 were from companies located in the United States, five from Canada, 15 from EMEA, three from APAC, and one from Latin America. The number of EMEA announcements were less than one-half of the prior quarter. Additionally, there were eight joint announcements by geography, three of which were in the U.S. and APAC. In the United States, 24 announcements were from companies in or near Silicon Valley, while seven were from London-based companies in the EMEA region.

With 43 citations, the most common type of announcement was once again funding-related, in addition to 27 product announcements and 37 merger and acquisition announcements. Funding announcements usually comprise about one-half of all announcements, but was down to 40% in Q3 2022.

Most announcements are traditionally funding for small or startup organizations, which was particularly true in the third quarter as there were only two announcements of at least \$100 million, down from 17 in 2Q 2022. The largest announcement came to \$200 million from Atlas, an Employment of Record (EOR) solutions provider located in Chicago, IL.




The next largest announcement came from HiBob for \$150 million. HiBob, launched in 2015, is an HR Technology Platform used by 2,500 multinational companies and claims the platform allows companies to streamline HR processes and engage top talent.

HCM/Core HR platforms, which includes recruiting outside of marketplace job boards, was the largest single area of investment, with \$260 million announced in the third quarter. There were 23 announcements related to HCM/Core for the third quarter of 2022, down from 35 in the second quarter of the year. Total investment in Marketplace Job Boards, the second largest area of investment, was \$159.2 million in the third quarter.

The third quarter of 2022 showed a remarkable decline in HR technology spending, one that accelerated throughout the year. But how will HR technology investment be impacted when the unemployment rate is near historic lows? In September, the U.S. unemployment rate edged down to 3.5 percent, as reported by the U.S. Bureau of Labor Statistics.³ In the UK, the unemployment rate has also decreased to 3.5%, the lowest level rate since 1974.⁴ Will those technologies focusing on recruitment become a larger part of the overall investment portfolio, or will that area decline proportionately along with the rest of HR technology investment if a global recession occurs? The fourth quarter of 2022 may provide some insight into that question.
