

Human Resources New Technology Quarterly Summary: Q1 2023



Introduction

Each quarter, new technologies in the HR space are developed and funded. To track the key players in the human capital management (HCM) technology sector and the innovation they bring, HRO Today produces quarterly reports summarizing the top advancements in the industry and the funding initiatives that support product innovation. This data reveals critical information about today's industry leaders, new technologies, and their applications.

The HCM systems covered in this summary include: recruitment, employee records, performance, learning and development, compensation management, and compliance tools. The quarterly report features new products hitting the market, funding announcements for companies providing HR technology solutions, and merger and acquisition (M&A) activity with direct implications for HR technology.



First Quarter 2023 Overview

The funding and development of HR technologies in the first quarter of 2023 did not provide a rapid start for the year. The comparatively low quarter follows on the heels of greatly reduced funding and development in the second half of 2022, and the pace may not rally until economic conditions improve. Overall, global funding decreased by 53% year-over-year. Additionally, first quarter funding in North America reached \$46.3 billion. One of the U.S.'s largest start-up investors, Silicon Valley Bank (SVB), collapsed on March 10, 2023, due to a lack of funds, which could further reduce the amount of available capital to fund new technology.

In total, there were 123 major announcements (those with at least \$1 million in funding) throughout the quarter, down from the 155 in the fourth quarter of 2022 and exactly one-half as many as the first quarter of 2022, which had 246 major announcements.

Private equity and venture capital firm's investment in HR technology totaled \$1.99 billion in the first quarter, up from the \$1.13 billion invested in the fourth quarter of 2022. However, it was less than one-half of the \$4.48 billion invested in the first quarter of 2022, excluding the five investments where the specific dollar amount of investment was not publicly available. The average investment in the first quarter was \$35 million, a drastic improvement from the \$19.4 million in the fourth quarter and slightly up from 2022's average of \$34.5 million.

Of the 123 technology announcements: 79 were from companies located in the United States, 20 from EMEA, 10 from APAC, and four from both Canada and from Latin America. Latin America is the only region to see an increase in technology announcements from the prior quarter. Additionally, there were six joint announcements by geography, three of which were in the U.S. and EMEA, the same as the fourth quarter of 2022. In the United States, 16 announcements were from companies in or near Silicon Valley, up from 13 in the fourth quarter of 2022. In the EMEA region, three announcements were from London-based companies.

The most frequent type of announcement was funding-related with 63 citations. In addition, there were 35 merger and acquisition announcements and 25 product announcements. Typically, funding announcements account for about one-half of all announcements. In the first quarter, funding announcements totaled 51%, an increase from 42% in the fourth quarter of 2022, and on par with the 53% from the first quarter of 2022.

In the first quarter of 2023, four funding announcements were over \$100 million, compared to only one in the fourth quarter of 2022. The largest announcement was \$500 million from Rippling, an HR and payroll platform located in San Francisco, California. Interestingly, the investment, primarily from Greenoaks, was a response to the collapse of SVB. The collapse, marking the second largest in U.S. history, left start-ups unable to continue operating, including Rippling. Without SVB's funds, Rippling was unable to automate payroll for their customers until the overnight funding round from Greenoaks.⁴



Payroll was the largest single area of investment, with \$906.3 million announced in the first quarter. Over one-half of this funding was for Rippling, caused by the collapse of SVB. There were 17 announcements related to payroll, up slightly from the 15 in the fourth quarter of 2022. The second largest area of investment was in Recruitment with \$762.3 million.

Worldwide economic instability has significantly impacted HR technology spending. As investors continue scaling back spending, the future of funding and developing HR technology remains uncertain. Recovery may be further stunted by the collapse of SVB, although the full extent of this may not be known until the end of 2023. ■
