

Human Resources New Technology Quarterly Summary: Q2 2023



Introduction

Each quarter, new technologies in the HR space are developed and funded. To track the key players in the human capital management (HCM) technology sector, and the innovation they bring, *HRO Today* produces quarterly reports summarizing the top advancements in the industry and the funding initiatives that support product innovation. This data reveals critical information about today's industry leaders, new technologies, and their applications.

The HCM systems covered in this summary include: recruitment, employee records, performance, learning and development, compensation management, and compliance tools. The quarterly report features new products hitting the market, funding announcements for companies providing HR technology solutions, and merger and acquisition (M&A) activity with direct implications for HR technology.



Second Quarter 2023 Overview

The second guarter of 2023 saw reduced funding of HR technologies. Year-over-year, HR technology investment fell by over 90%, partially due to high levels of funding-related announcements in the first half of 2022. Comparatively, 2023 has seen grim levels of funding. However, these past funding rounds led to an increase in HR technology development, perhaps signaling a new trend during global economic difficulty. Funding in North America fell to its lowest point in over three years and funding fell 50% year-over-year as \$31.8 billion was invested. Additionally, investors completed the lowest number of deals in nearly two years.¹ Globally, venture funding decreased by 18% quarter-over-quarter, and 49% year-over-year, to \$65 billion.² Interestingly, early-stage investment levels were steady. Going forward, smaller, early-stage investments may take precedence over larger, late-stage funding.

In total, there were 142 major announcements (those with at least \$1 million in funding) throughout the quarter, up from 123 in the first quarter of 2023, but down from the 174 announcements in the second quarter of 2022. Private equity and venture capital firms' investment in HR technology totaled \$457.35 million, down significantly from the 1.99 billion invested in the first quarter of 2023 and the \$4.70 billion invested in the second quarter of 2022.

Investment in the first half of 2023 decreased dramatically from the first half of 2022, down from \$9.18 billion to \$2.45 billion. The average investment in the first quarter was \$11.15 million, down from the \$35 million in the first quarter.

Of the 142 technology announcements: 99 were from companies in the United States, 20 from EMEA, seven from APAC, and three from Canada. There were no announcements from Latin America. The U.S. was the only region to see an increase in technology announcements from the prior quarter. Additionally, there were 13 joint announcements by geography, over twice as many from the previous quarter. Nine of the 13 were in the U.S. and EMEA. In the United States, 27 announcements were from companies located in or near Silicon Valley, up significantly from the 16 in the first quarter of 2023. From the EMEA region, nine announcements were from London-based companies.

The second quarter of 2023 saw a shift from funding-related announcements to product announcements. Overall, there were 53 product announcements, over double the number in the first quarter. Additionally, there were 46 merger and acquisition announcements and 43 funding-related announcements. Typically, funding announcements account for around one-half of all announcements. However, in the second quarter, funding announcements totaled

30%, down from 51% in the first quarter. Product announcements made up 37% of citations, compared to 20% in the first quarter of 2023. This influx of product development may be the result of high funding rounds throughout the first half of 2022.

In the second quarter of 2023, there were no announcements over \$100 million, compared to four in the first quarter. The largest announcement was \$90 million from Synthesia, an Al-based professional and instructional video creation platform located in London, UK.

Marketplace Job Boards was the largest single area of investment, with \$138.4 million announced in the second quarter. There were 12 announcements related to marketplace job boards, down from the 15 in the first quarter of 2023. In the first half of 2023, Marketplace Job Boards received \$209.7 million in funding with 27 citations. Again, the second largest

area of investment was in Recruitment with \$125.9 million. Interestingly, Recruitment saw the highest number of product announcements with 20 citations. There were 98 Recruitment announcements in the first half of the year, and funding totaled \$888.2 million.


HR technologies, like other sectors, have seen a recent increase in utilizing Artificial Intelligence (Al). From the 1Q'23 to 2Q'23, the number of citations including Al has nearly doubled, from 19 to 33. Additionally, funding in this area has nearly tripled from \$96.9 million to \$276.2 million. Al-based technologies may continue dominating future announcements.

A major influx of HR funding throughout 2022, coupled with recent economic instability, led to an increase in product developments. Due to recent economic uncertainty, investors seem hesitant to commit to larger funding rounds. Going forward, these trends will be imperative to understanding the new landscape for funding and developing HR technologies.
