

Human Resources New Technology Quarterly Summary: Q1 2025



Introduction

Each quarter, new technologies in the HR space are developed and funded. To track the key players in the HR technology sector, and the innovation they bring, *HRO Today* produces quarterly reports summarizing the top advancements in the industry and the funding initiatives that support product innovation. This data reveals critical information about today's industry leaders, new technologies, and their applications.

The HR tech covered in this summary includes recruitment, employee records, performance, learning and development, compensation management, and compliance tools. The quarterly report features new products that hit the market, as well as funding and acquisition announcements for HR tech companies.

First Quarter 2025 Overview

HR technology announcements started the year slowly. Product activity was, again, the strongest section of activity. Venture capital (VC) activity slowed down as total investment and average investment decreased to \$802.9 million. Mergers and acquisitions (M&A) activity slowed considerably, to 28, especially after a robust showing in 2024.

Overall, venture capital funding has seemingly bounced back after reaching its highest level since 2022. Although total deal count has decreased, global funding reached \$121 billion in the first quarter of 2025. This growth was driven by mega-rounds, or deals worth over \$100 million, as they accounted for over 70% of funding.¹

North America had a promising quarter as funding reached \$80 million, accounting for 71% of all global funding. Silicon Valley-based companies accounted for 69% of US-based VC activity, further cementing the region's position for innovation and funding.

M&A activity had its strongest quarter since 2021. Globally, M&A seemingly rebounded, though activity was led by Google's acquisition of Wiz for \$32 billion, the largest acquisition of a private company in history.² Due to global uncertainty, economists believe M&A deals might decline, though the number of deals is expected to pick up again by the end of 2025.³

There was a total of 159 major HR technology announcements in the first quarter of 2025, a decrease from the 202 announcements in the fourth quarter and 175 in the first quarter of 2024. Major announcements included those with at least \$1 million in funding, where funding information was available.

Overall, investors made fewer deals and for lower amounts in the first quarter of 2025. Investment in HR technology totaled \$802.90 million, down from \$1.11 billion invested in the fourth quarter of 2024 but up from \$644.70 million invested in the first quarter of 2024. The average investment in the first quarter was \$22.94 million, down from \$28.54 million in the fourth quarter of 2024 but up from the \$14.99 million in the first quarter of 2024. There were four announcements over \$100 million. The largest announcement was \$140 million for Darwinbox, an HR technology platform.

There were 35 funding announcements, down from 39 in the fourth quarter and 45 in the first quarter of 2024. There were 28 M&A announcements, down significantly from 48 last quarter. Products made up the majority of announcements, with 96 new products debuting, down from 120 in the fourth quarter but up from 96 in the first quarter of 2022.

As the influx of new HR technology products continues, product announcements now account for roughly one-half to two-thirds of all announcements. This quarter, products accounted for 60% of announcements, up from 59% last quarter and 51% in the first quarter of 2024. Historically, until 2023, funding announcements accounted for about one-half of announcements. However, funding announcements now make up 22% of all announcements this quarter, up from 19% last quarter but down from 26% year-over-year.

The recent expansion of AI technologies and capabilities has increased the total number of HR products launched.

The recent expansion of AI technologies and capabilities has increased the total number of HR products launched. Funding began to wane in 2023 as companies turned to internal product development, fueled by the availability of AI technologies. Now, AI-based companies account for 20% of all funding. Companies are now integrating AI, updating systems, and launching AI-based products to stay competitive and draw in funding.

Of the 159 technology announcements, 124 were from companies within the United States, 18 from EMEA, 5 from Canada, 4 from APAC and one from Latin America. There were 7 interregional joint announcements: 5 between the US and EMEA, one between the US and Latin America, and one between APAC and Canada. Silicon Valley was active again, with 32 announcements compared to 34 last quarter. However, activity in London weakened with three announcements compared to 9 last quarter.

HCM/Core HR technology and Talent Acquisition technology had strong performances in the first quarter of 2025. Talent Acquisition technology had the most announcements, 54, while HCM/Core HR technology had the largest amount invested, 358.50 million.

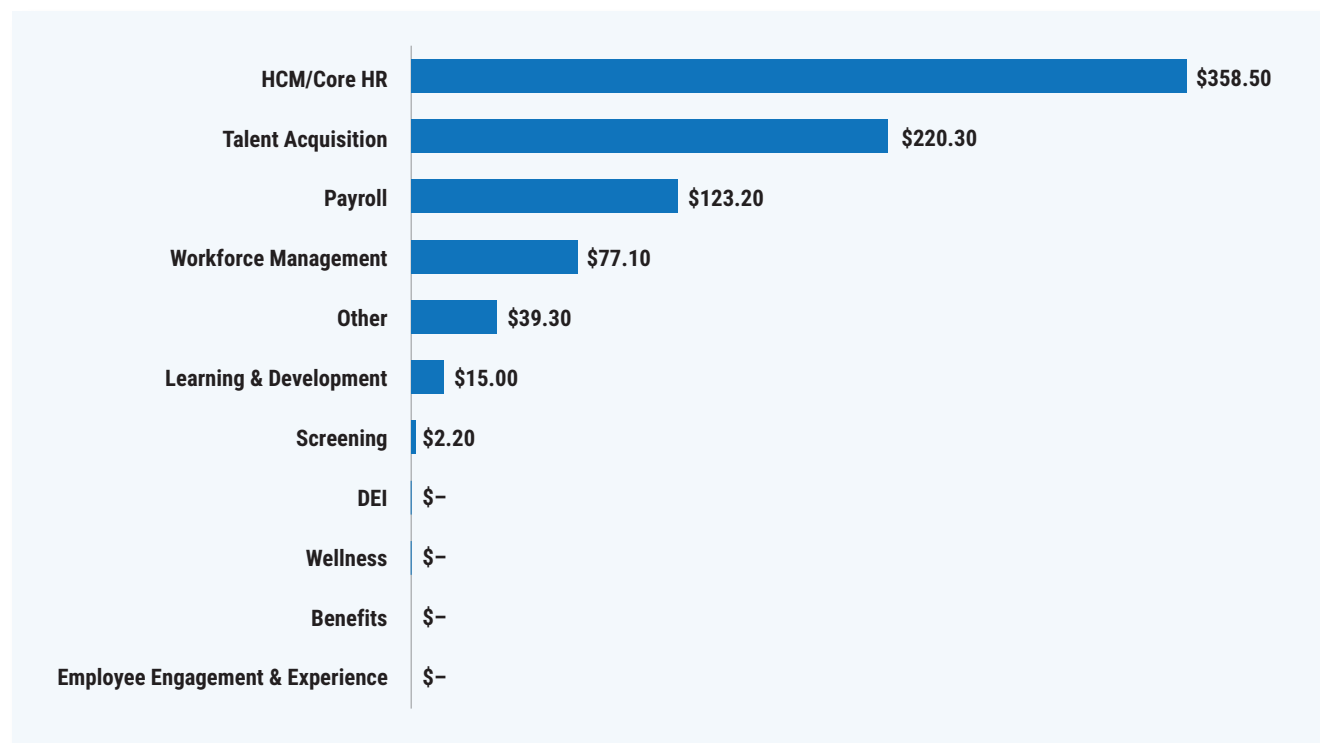

In the last few quarters, Talent Acquisition technology has had significant growth in investments and product announcements. HCM/Core HR technology has had an influx of new product announcements and funding, mainly fueled by AI integration.[†]

Based on first quarter technology announcements, 2025 will be a promising year for HR product announcements. HR technology funding has not yet bounced back from its recent decline and further economic uncertainty does not allow a clear timeline for funding to return to its previous levels. Talent acquisition and core HR functions continue leading in investment and technology announcements, reflecting current needs within the labor market. Throughout 2025, HR technology should experience growth paired with innovation. ■

[†] In this report, and in the following, we have renamed and consolidated the categories. Talent Acquisition now includes recruitment and marketplace job boards. Learning & Development includes upskilling and assessments. Employee Engagement & Experience are now combined. Wellness includes physical, mental, and financial health. Other includes collaboration and communication, team building, relocation, contingent, and compliance. In previous years, we included an AI category to measure the growth of AI in HR tech. However, AI is rapidly becoming table stakes in modern technology. Due to this fact, along with the fairly liberal use of the term in the media, the category of AI will not be specifically broken out in our analyses going forward.
